INDEMNITY

I, the undersigned, _____
(Herein after referred to as "the participant")

ID No: _____ do hereby indemnify Red Ivory Safaris, its members, agents, employees, guests, servants, competitors and other using the concession area, against any loss, damage or injury of any nature which I may suffer while on the concession area, under the control or custody of Red Ivory Safaris.

1. The participant is aware and fully realizes that a grave risk exists of him being injured or killed or all or any of his property being damaged or destroyed before, during or after hunting activity as a result of alias, the use of firearms, motor vehicles or any other equipment of any nature whatsoever, the food such participant may eat or liquids he may drink or being bitten by dangerous animals or insects, or as a result of lack of care or skill or the negligence, recklessness or for whatever reason of Red Ivory Safaris its members, agents, employees, guests and servants and including other persons using the concession area.
2. The participant agrees that notwithstanding the knowledge and the appreciation at risk and danger involved, that he is still desirous to participate in the hunting activity, or to be present while any activity is conducted on the concession area of Red Ivory Safaris, and hereby waive all claims of any nature whatsoever which may arise out of his participation or his presence whilst on the concession area of Red Ivory Safaris.
3. The participant accordingly waives any claim of any nature whatsoever against Red Ivory Safaris its members, agents, employees, servants, guests, competitors and others using the concession area, and/or the landowners on whose property hunting activity takes place and also their agents, employees and servants arising before during or after such hunting activity from any cause whatsoever.
4. The participant hereby indemnifies and holds harmless Red Ivory Safaris its members, agents, employees, servants, guests, competitors and others using the concession area, and/or the landowners on whose property hunting activity takes place and also against any claims of any nature whatsoever from any cause arising which may be instituted for the recovery of any loss or damage whatsoever.
5. The participant warrants that he has full authority to waive on behalf of and to represent all the members of his family and/or dependent who have a claim against Red Ivory Safaris.
6. The participant authorize any person or officer appointed by Red Ivory Safaris in his name, place and stead, to act at his sole discretion on his behalf in the event of any emergency which may occur and result him being unable to act on his behalf while on the concession area of Red Ivory Safaris.
7. I undertake to abide by the discretion of the Professional hunter in those cases where he is of the opinion that our situation is life threatening and steps need to be taken to ensure that our/the safety is guaranteed. I undertake to pay any reasonable costs associated with the steps needed to ensure our personal safety during the hunt should our safety be threatened by a wild animal and the game owner has to be compensated for the loss of the animal.

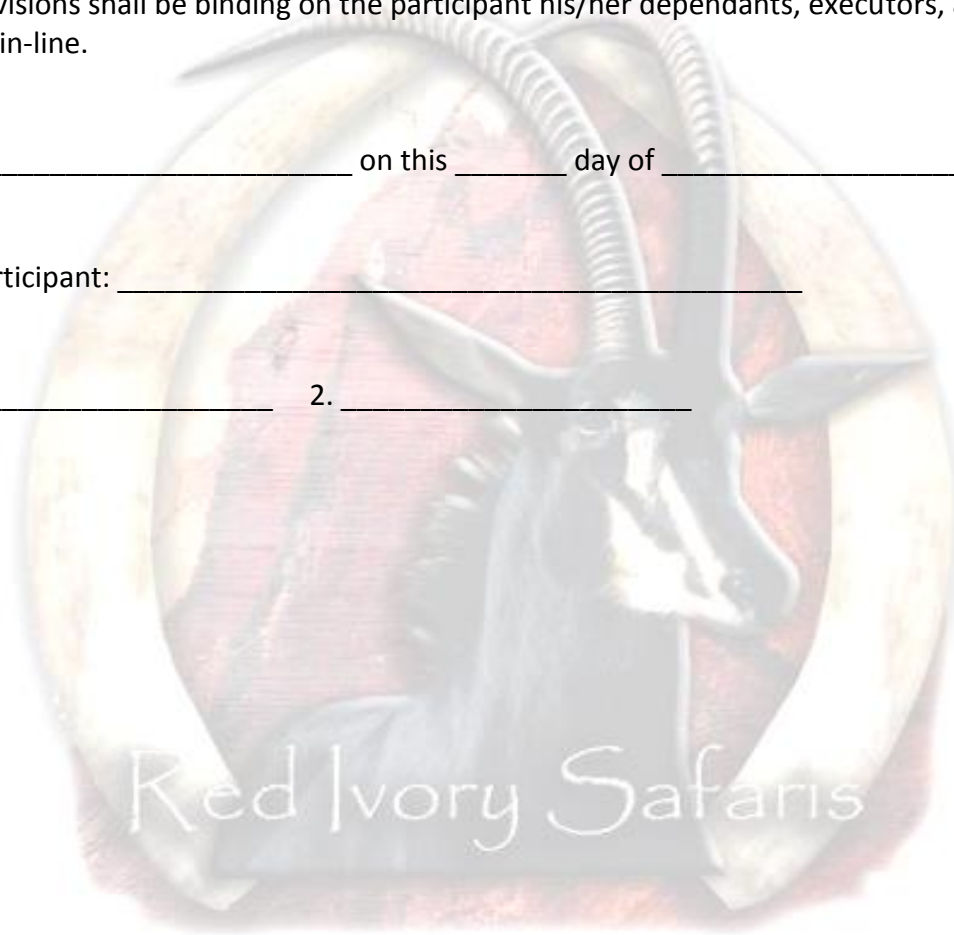

I undertake to pay all costs involved/associated with the steps taken on wounded game by the Professional Hunter, and to compensate for the animal taken by the Professional Hunter.

Each of these undertakings and covenants is separated from each of the other undertakings and covenants and should any provisions of this agreement not be upheld it shall not limit the enforceability of such other provisions. Each of the provisions shall be binding on the participant his/her dependants, executors, administrators, heirs and successors-in-line.
